Judging will take place on the Outside Stage at the Cass County 4-H Fairgrounds on Wednesday, July 9, 2025 at 6:00 p.m. (If rained out, contest will be held Thursday, July 10, 2025 at the same location and time.)

Each participant should dress in "cowboy and cowgirl" style clothing including boots, cowboy hats, and assorted western attire. They may choose to wear jeans, shirts, skirts, dresses, chaps, or vests. They may also choose assorted western accessories such as lariats, spurs, etc. NO WEAPONS OF ANY KIND MAY BE WORN OR USED AS AN ACCESSORY AND NO LIVE ANIMALS WILL BE ALLOWED.

Each participant must pay a non-refundable \$10.00 entry fee (or \$15.00 per family). Payment should be made by check or money order (payable to the "Cass County 4-H Club Association").
